The personal data included in our databases, that obtained during the daily and normal activities, and that delivered voluntarily by the personal data owners in response to a request, will be treated according to the principles, duties, and guidelines contained in Law 1581 of 2012 and in other norms related to and regulating this issue.

CH MAC Abogados will be responsible for the treatment given to the owners' personal data, which such owners will be able to address in order to properly exercise their access, rectification, update, deletion, and revocation of the data treatment authorization rights, as well as those contained in Law 1581 of 2012, especially in Article 8 of said Law. The information now being collected will be used for the following purposes:

- Comply with the commercial and contractual activities related to CH MAC Abogados
- Issue invoices, quotations, records, and all the documents required to support the CH MAC Abogados accounting records.
- Develop accounting processes and procedures.
- Comply with the security processes related to the information contained in the CH MAC Abogados databases.
- Client data: Render the services contracted by the clients, report on the state of the contracted services, their amendments and new events, update the contact information, and deliver the products requested by the clients.



- Supplier's Data: Issue purchase orders and pay the suppliers; report the tax information and execute the contracts existing between CH MAC Abogados and its Suppliers.
